**138-16 ADMINISTRATIVE STRUCTURE CHANGE (LCMS/LCHS)**

Rationale:  
Dr. Evans will discuss consolidation of Lee County Middle School and Lee County High School Administrative Structure and request authorization to take next steps due to:

Declining student enrollment  
PLA status ends  
One governing SBDM

Reporting for one facility  
Current Tentative Budget Status  
Danger of Falling below 2%  
Combining both schools will provide the opportunity to maximum staff and facility space

Three Options:

1. Superintendent Recommendation - Consolidate Lee County Middle and Lee County High School into six-twelve and have one Principal and one Assistant Principal (This option would allow the principal time needed to focus on staff and instruction while the assistant principal concentrates on students and discipline). District administrators and current principal spoke to the benefits of this as the best option.
2. Eliminate Assistant Principal Position and have one Principal at each building
3. Continue current Administrative Structure (will be under the required 2% contingency with this option)
